

Ken Agyapong Goes Into Hiding, Court Chases Him Over Criminal Contempt



he Accra High
Court has ordered Assin
Central MP Kennedy
Agyapong to appear before the court on Friday,
September 18, 2020,
after the loudmouthed
MP had apparently
dodged his appearance
in court today.

According to excuses from Mr. Agyapong's lawyers, Mr. Agyapong was not personally served with the writ asking him to appear

before the High Court on serious contempt charges.

The court has therefore issued a fresh order, saying the writ and the hearing notice will be posted "on conspicuous part of Net 2 TV and Oman FM stations, Hollywood Building". These are media outfits owned by the embattled MP.

The refusal of Mr. Agyapong to appear before the court rein-

forces speculations that President Akufo Addo and the Jubilee House was pulling strings to let the lose-talking MP walk free.

Kennedy Agyapong was in court over a land dispute, however, while the case is still ongoing, he went on his Net 2 TV and started raining strong expletives at the judge sitting on the case, describing him as stupid and corrupt.

"You are a stupid

judge. I will face you," Ken Agyapong said on the programme.

This attack has drawn serious angst within the Ghanaian judiciary with a cross-section wanting him to be slapped a harsh jail term to deter others from feeding off the dangerous precedence.

"Your Lordship, that, Mr Agyapong's conduct is graver in scope and impact than the infamous 'Montie 3'. This is because of the influence he wields and the coverage of the channel on which he made these dangerous comments compared to the 'Montie 3' in these respects. A strong action against Mr. Kennedy Agyapong is necessary to establish the independence and authority of the courts and to deter persons in future from acting in an analogous manner," lustice Issifu wrote in a petition that has since been copied to the President and the higher echelon of Ghana's government.

Mahama Admits Shock In Infamous BBC Corruption Interview



x-President and flagbearer of the opposition National Democratic Congress (NDC), John Dramani Mahama has finally admitted that how he goofed during the infamous 2016 BBC interview that cornered him about corruption under his regime.

In an interview on Accra-based Class FM, ex-President Mahama explained that the BBC's Peter Okwoche had ambushed him with the "discourteous" question that sought to pin his administration to the raging allegations of corruption at the time.

"...of course it threw me off the cuff, it was a question about have you taken a

bribe before? it caught me off guard I'll tell you that. I answered it and try to clarify the question but he kept persisting and I said no I haven't. Of course, people took advantage of that and made a lot of noise about it."

In that interview, Peter Okoche pinned the ex-President down with a direct question on whether he had taken a Ford vehicle bribe he is being accused of or not. The ensuing embarrassing hesitation and stuttering from the ex-president sparked a storm in Ghana.

BBC's Peter Okwoche, asked him directly if he has taken bribe, President Mahama responded, "You mean as President?" to which Peter Okoche pressed on: "As John Mahama," he clarified. The follow-up response from ex-President Mahama turned up an awkward look on the face of the clearly fluttered John Mahama, who once more: "You mean as a human being?"

He later went on a winding explanation that did nothing to ease the intense speculations back home in Ghana. He said: "Any human being in the world would have encountered corruption one way or the other, either being offered a bribe or a bribe being demanded from you. What you need to do is to put yourself in a

position to (resist it)..."

The mischievous Peter Okwoche was unrelenting and intent o an unrealistic hope of getting the ex-President to admit anything on international airwaves. Eventually, he blurted out: "no, I haven't taken bribe before."

In May 2020, a former Presidential Aide, Stan Dogbe in an Interview with Joy FM explained that Mr. Mahama was not supposed to have taken that interview with the BBC because neither him as the then-presidential aide on communications nor the then-Communications Minister, Dr. Edward Omane Boamah knew about that interview.

Apparently, the interview that became one of ex-President Mahama's lowest points in the election year of 2016, was not part of the entourage's itinerary on their trip to London.

It was basically an ambush by the BBC, Mr. Dogbe said.

"It's one of the interviews that the President should not have. It's because he did not go there for an interview In those moments, I tell you from my experience, the president doesn't have to say much. A yes or no can damage the narrative you want to put out there," Stan Dogbe revealed.

Akufo Addo's Electoral Fortunes Weakening in Eastern, Bono, Central Accra

local election pollster Vote233 is warning the governing New Patriotic Party (NPP) that its Presidential Candidate, Nana Akufo Addo's popularity is slowly waning in three important regions: Easter, Bono, Central and Greater Accra Regions.

In the latest survey conducted in August 2020 and posted on the group's website, President Akufo Addo's fortunes in the newly created Bono Region dropped from 63.8% to 55%; in the Eastern Region from 91% to 82%; in the Central Region from 48.6% to 47% and in the Greater Accra Region, the NPP's election potentials have declined from 47.5% chance to 41%.

However, overall,
Vote233 is tipping the NPP
presidential candidate to
win the December 2020
presidential election by a
wide margin of some 46.6%
against 24.8% of his closest
rival from the opposition National Democratic Congress
(NDC), ex-President John
Dramani Mahama.

However, this poll is still inconclusive in safely determining the outcome of the presidential race because there is a huge number of undecided voters: 20%.

It is unclear where the preferences of these undecided voters will swing to. A mass movement to any of





the two frontline presidential candidates could easily change the outcome of the elections in December.

"Overall, Nana Addo's chances improved in 7 regions, dropped in 4 and remained relatively unchanged in 5. This is why our forecast gives him a slight edge in the December polls. As of writing, our model gives him a 6 in 10 chance of winning the elections — not a bad place to be 3 months out from the election," Vote233 stated.

According to the pollsters, President Akufo Addo should better pray that President Mahama does not up his game and make the race any more competitive than it was as at August 2020 "The challenge for Nana Addo is to fight off any attempts by John Mahama to make the any more competitive. The closer his chances get to 50%, the more unpredictable the race becomes," Vote233 noted.

However, President
Akufo Addo's worst fears
may have just happened
some three weeks ago when
it launched its 2020 manifesto with the NDC launching
theirs some two weeks ago.

The NDC Manifesto appears to have ignited the competition with John Mahama pledging to legalise commercial motorcycle business that hundreds of thousands depend on and additional promises that seek to eclipse the NPP's flagship policies, such as the planned extension of Free Senior High School education to include private schools; paying part of the tuition of university students; making technical education free of charge and broadening the base of legal education in Ghana.

Indeed, these promises have struck fear in the NPP

such that the governing party which initially insisted that it will continue to proscribe commercial motorcycles as an illegal business. However, the groundswell and positive response to the promise has forced the NPP to do a ridiculous U-turn that has got Ghanaians noticing that the ruling party is terrified by the trump card pulled by the NDC.

Additionally, the NPP Vice Presidential Candidate, Dr. Mahamudu Bawumia has further muddied the waters for the governing party, when he presented the party's "Infrastructure Tracker". Out of the 17,000 projects he claimed the Akufo Addo government had implemented, it has been discovered that a significant bulk are either non-existent or were projects initiated by the erstwhile NDC administration headed by John Dramani Mahama.

No Work On Apowa-Mpohor-Adum Banso Road After Prez Cuts Sod In 2018



Apowa-Mpo-hor-Adum Banso road has become a one more White Elephant as the dirt road continues to sit abandoned, two years after President Akufo-Addo cut sod for its construction.

The 16km stretch is in the political stronghold of the governing New Patriotic Party (NPP) and residents have reportedly lost hopes of the road being built. But even more significant, the people of the area feel their Member of Parliament has been insulting their intelligence with the promised road works that has never happened.

In March this year, when the NPP was gearing up for its Parliamentary primaries, Hon Alex Kofi Agyekum, mounted a huge signboard suddenly announcing that the road had been offered on contract.

According to the signboard, the road engineers to work on the stretch were a certain Francis Engineering Services Ltd. However, by this time, the people had grown tired.

And so refusing to have their intelligence insulted anymore, some townsfolk have pointed it out to the MP that they knew that it was his desire for re-election on the NPP ticket that has led to his mounting the signboard making the fake announcement two years after the President had cut sod for the road works.

In 2018, President Akufo-Addo cut the sod for work to begin. Two years after the pomp and pageantry, nothing else has happened on the road.

It Is Easy To Jail Ken Agyapong On Contempt Charges...Amb. Haruna Atta

hana's former High Commission for Namibia with accreditation to Botswana, Amb Abdul Rahman Haruna Attah, has observed the High Court has good judicial precedent to guide it to jail the Member of Parliament for Assin Central, Ken Agyapong, for contempt.

In a write-up, the veteran journalist pointed out that there are many decided contempt cases within the Judicial memory which are exemplary, adding that the recent most topical involving the so-called 'Montie 3' lends itself to reference for the court.

"Almost four years ago, to the day, another case, a carbon-copy of the one being heard today, was enacted in the chambers of the highest court. As precedents go, the court hearing today's contempt case would not have far to go. The so-called Montie 3 docket, judgment and sentencing are there to guide the court," the former diplomat wrote.

He pointed out that just like Kennedy Agyapong has apologized for calling judges "stupid" on-air, Muntie 3 had similarly apologized for threatening judges but were still jailed.

"The politician has since apologized, so did the



Montie 3, which was not enough to tamper justice with mercy."

Mr. Kennedy Agyapong, MP for Assin Central has been cited by the Accra High Court (Land Court 12) for saying a trial judge in a land case involving him was "stupid" among other expletives.

Mr. Agyapong, prejudicially commenting on a land case in which he had been sued, took the trial judge to the cleaners on his Net 2 TV station for the judge's grant of an inter-

locutory injunction against him.

Susan Bandoh and Christopher Akuetteh Kotei who had sued the Assin Central MP, one Ibrahim Jaja, Nana Yaw Duodu aka Sledge and the Inspector General of Police had secured the injunction against the MP.

In reaction, a vintage Ken Agyapong exploded, insulting the trial judge in shocking language that has been said to be totally unbecoming of a lawmaker.

"Listen to the reason why I am angry. The lawyer wrote the thing on August 5, and the judge scheduled appearance on August 13. I didn't get anything from them; then on September 1, you granted an injunction on the property. You are a stupid judge; I will face you. You are a stupid judge," he fumed.

"You think I fear someone? I am not like Anas who will take a bribe from you. I will deal with you... nobody served me anything. I didn't know what was going on. Then all of a sudden you say I should not go to the land. You are an animal of a judge."

The court took notice and cited him for contempt. The MP has since written an apology to the Chief Justice, however, the public has been demanding for his neck

Amb. Haruna Attah points out in his writing that the angry public, including judges and law dons, who are demanding that Ken Agyapong be made to face Justice, do not include some very vociferous ones who chanted for a pound of flesh when Safifu Maase, Alistair Nelson and Godwin Ako Gunn, were similarly cited for contempt for verbally attacking judges on Montie FM.

"Even an institution like the Catholic Church, which trades in mercy and such holy things, jumped into the fray and backed the court to insist on its pound of flesh. God is not an entity to be used in partisan politics, so today He is looking on from on high to hear what His representatives on earth are saying on this one... where are their voices today? Where are their cries of self-righteous indignation? Has Nana Akufo-Addo got such a hold on their consciences?" Amb. Haruna Attah wrote.

Meanwhile, it has been alleged that President Akufo-Addo has directed Chief Justice Kwasi Anin Yeboah to ensure that Ken Agyapong, a bankroller of the NPP is not jailed.

Ghanaian Pastor Who Shot Wife In The US May Get Death Penalty Or 145 Yrs In jail

...wife was allegedly bonking Church Choir Director

ylvester Ofori, the Ghanaian Pastor who shot his wife to death in Florida, USA, is likely to get the Capital Punishment, according to reports.

What this means is that he faces the likely hood of being singed in an electrical chair, facing firing squad, lethal injection, decapitation or the hangman's noose.

If he escapes execution, then he is likely to face 145 years in prison with hard labor, for putting seven bullets into his own wife.

The information is coming from investigative media outlets in the US who are pointing out that Florida's continuation to be one of a few US States which still have Capital punishment in their criminal codes means that the Ghanaian preacher is likely to be in for the ultimate.

According to reports, the trial judge has taken the position that the murder was not only dastardly, but premeditated because Pastor Sylvester Ofori, could have backed off after shooting his wife, Bar-



bara Tommey, for the first time, but rather closed in and put six more bullets in her.

Capital Punishment has been part of Florida's criminal penalty system since 1979 when it was first applied for the execution of a murderer and has since remained in the State's penalty codes in spite of campaigns by the United Nations and Civil Society Organizations, including Amnesty International, for the abolishment of the death penalty in the world.

The last time the death penalty of Florida was handed down was last year, when two people, Bobby Lowlong, and Garry

Ray Boss were executed for murder. Lowlong had allegedly murdered 15.

Meanwhile, it has emerged that the reason for the murderous shooting of Preacher's Wife, Barbara Tommey, 35, was because she was cheating on the husband.

According to reports,
Barbara was pregnant at
the time of her shooting,
but not for her husband.
She was pregnant for Choir
Master of the Church that
Sylvester Ofori Pastored.

The man of God was said to have been incensed when his wife, sent him nude pictures and video that she had intended for the Choir Master lover. In

the video, she was allegedly seen having sex with the Choir master lover in a Jacuzzi in her matrimonial home.

She had allegedly accompanied the video and nude photos and sex video with some flirty words for the lover, but had mistakenly sent it to her husband instead. The mistake cost her, her life.

The Police in Florida is said to have also corrected reports that Pastor Sylvester Ofori handed himself in after the murder, saying, he was arrested in his home by the Police which had invaded there with a Special Weapons and Tactics (SWAT) team.

Police Squash Demo By ASEPA Over Agyapa "Sakawa" Deal

he Greater Accra Regional Police Command has disallowed a planned demonstration by Civil Society Organization, Alliance for Social Equity and Public Accountability (ASEPA) against the Agyapa Mineral Royalties deal.

In a response to ASE-PA's notification of intent to lead 20,000 into the streets to demonstrate displeasure over the deal which has been attributed to the so-called "Akyem Sakawa", the Police said Covid-19 is an extenuating circumstance.

"The Command wishes to inform you that restrictions imposed on public gatherings of more than two hundred (200) people without face mask due to the Covid-19 pandemic has not been fully lifted. You are further informed that for twenty thousand (20,000) people to gather for a demonstration, there is the tendency that Covbid-19 protocols would be breached. If permitted to demonstrate in this manner, public health and security could be endangered," said the letter signed by



ACP E. A. Sakyi, Assistant regional Commander.

Interestingly, the denial of way to ASEPA to demonstrate over the Agyapa deal by the Police is coming after supposed Akyems in the Eastern Region had last week been granted permission by the same Ghana Police to demonstrate over the same Agyapa deal, in Asamankese.

The demonstrators who have been variously described as "NPP zealots" and "NPP Hirelings," had poured into the streets of Asamankese wielding placards, firing



guns and virtually going without face masks.

The Akyem demonstrators had attacked former President John Mahama for re-posting a Facebook post by the MP for Bolgatanaga Central, Isaac Adongo, in which he had written that the Agyapa deal is being sponsored the "Akyem Sakawa Mafia."

The Akyem Sakawa Mafia supposedly has President Akufo-Addo as head honcho. It is believed that the Agyapa Minerals Royalties deal, which aims to perpetually give out 49% of Ghana's mining royalties to investors (who are suspected to be the Akufo-Addo family ruling Ghana and their friends) is aimed to forever keep Ghana's mineral wealth in the hands of the Mafia.

The Government's deliberate obscurantism after it chose a tax haven in the UK as the place to incorporate the foreign entity of Agyapa has led many to conclude that the deal is a dirty plot in what is seen as a larger State capture by the Akyem Mafia.

ASEPA had written to the Police today, in accordance with the Public Order Act (491) to inform the Police of its intent to organize a civil demonstration after the government snubbed calls by a group of Civil Society Organizations to drop the deal two weeks ago.

However, the Ghana Police which granted supposed unhappy Akyems to demonstrate in Asamankeses last week over the Agyapa deal, has claimed that ASEPA's demonstration will breed more Covid-19.

EC Sets Ghc100,000 As Filing Fee For Presidential Candidates

...Independent Candidates, smaller parties now under trap to run to Akufo-Addo



hana's Electoral
Commission has
announced that
in the 2020 elections, a
Candidate aspiring to
be President must pay
money huge enough to
be used to buy a house
as filing fee.

Presidential Candidates will have to cough a whopping Ghc100,000 (1billion old cedis) as filing fee.

Mrs. Jean Mensah, Chairperson of the Electoral Commission announced the fees today while announcing the opening of nominations for the Presidential and Parliamentary elections today.

Parliamentary Candidates on the other hand are to payGhc10,000 each as filing fee.

The Ghc100,000 figure is jump from Ghc50,000 that had been charged by the EC for the 2016 Presidential election, over which the then opposition New Patriotic Party (NPP), remonstrated over.

WhatsUp News is in firm intel that the outrageous price tag that Jean Adukwei Mensah has slapped on democracy is intentional and coached by Flagstaff House.

According to sources, the plan is to strangulate the pockets of smaller parties and independent Candidates so that they can run to the Akufo-Addo Jubilee House for help. This way, the President will have the latitude to demand electoral allegiance in exchange for being plied with the largesse of State money.

But the Deputy
Chairman of the EC in
charge of Corporate
Services, Dr. Bossman
Eric Asare, has already
jumped to the defense
of the astronomical
amount saying the
Ghc100,000 filing fee
is rather a generous
amount.

According Dr. Asare, the depreciation of thye cedi is to blame for the huge filing fee.

"We did not increase because we can, but frankly, every four years we adjust the prices as far as the nomination fees are concerned.

"So in 2012 presidential was almost ¢10,000, 2016, it came to ¢50,000 and in 2020 it is now ¢100,000. And those of you who know the value of money in each particular year, it is important you look at the value of ¢50,000 in 2016 and compare to the same amount to now and you will know that the Commission has not increased it that much," he said.

Meanwhile, Mrs.
Jean Mensah said nomination forms for both
presidential and parliamentary aspirants can
be accessed online.

"Each political party would be given a unique password and the password would be given to the general secretaries so they can access the forms online.

"Also, Independent Candidates will be given passwords so they can access the website and fill the form between October 5 to October 9."


