## "AKYEM SAKAWA" Complaints Explodes In President Akufo Addo's Face

resident Akufo Addo's strong condemnation of the reference to him and his close circles as "Akyem Sakawa" for their reported roles in the scandalous Agyapa Royalties deal has taken a turn for the worse, as the President has been called out for the very ethnocentrism he sought to condemn.

A visibly angry President Akufo-Addo has expressed his frustration after ex-President John Mahama posted an article on social media authored by Bolga Central MP, Isaac Adongo on the controversial Agyapa Royalties deal. Mr Adongo described the proponents of the deal that aims to clandestinely rob Ghana of its mining royalties as "Akyem Sakawa people".

President Akufo Addo had latched onto the Akyen ethnic group mentioned in the statement as an exhibition of ethnic prejudice by the ex-President.

"Presidential candidate, a former President of Ghana, you can call a group of Ghanaians "sakawa people", and it involves the group for which the sitting President comes, and that statement goes without comment, and at the same time we hear all these statements, "let all try and bring the politics of



insults to an end."

However, Mr. Mahama, who is the flagbearer of the opposition National Democratic Congress (NDC) has fired back at the President, saying he has no moral right to condemn ethnocentrism.

"In any case, President
Nana Akufo-Addo has lost
the right to complain a long
time ago. He was an opposition leader who called
Presidents before him
anything you can imagine
including Prof. Do Little and
he described somebody as
'Simpa Panin' and I don't
want to repeat some of the
things he said. He is a President who has called his
critics naysayers and Jeremiahs, I don't understand

what standard he can be offended at this time because he has precedence of name-calling," Mr. Mahama fired.

Mahama went on to note that he had worked closely with several people from the Akyem ethnic group and thus has nothing against the people: "In the first place, the National Chairman of my party, Samuel Ofosu Ampofo is an Akyem and so are many leading members and supporters of my party. When I was President I appointed many Akyems in my government. The Head of our manifesto drafting committee Prof. Danso Boafo is an Akyem and they have all contributed to our government and forward march to recapture power in December in order that we can create jobs, spread development in an equitable manner throughout the country."

Meanwhile, a youth group in the Northern Region has also called out President Akufo Addo as the one who was ethnocentric.

In President Akufo Addo's condemnation of ethnocentrism, he had made a snide reference to some ethnic groups in the North, saying: "If I was to get up to make a comment about Northerners or Gonjas, you can imagine the uproar that will be in this country."

According to the group in response, the President betrayed his own ethnocentrism by referring to Northerners the way he did. "As much as we acknowledge the context in which the President tried to situate his comment, we suspect his generalization to encompass all Northerners has underpinning sentiments. It is in this respect we disagree with the President and call on him to explain his bitterness against Northerners or Gonjas," stated Mohammed Nuhu for the Northern Youth group.

### Noguchi Distances Self From Outragoeus COVID-19 test at Kotoka

Memorial Institute for Medical Research (NMIMR) has distanced itself from statements made by one of its scientists who revealed the US\$ 150 Covid-19 test rip-off of arriving international travellers at the Kotoka International Airport (KIA),

Noguchi has said in a statement that it was Dr. Kofi Bonney's own personal opinion when he made claims that half of the antigen tests to be conducted at the airport may be inaccurate, and that the US\$150 price tag for Covid-19 tests at KIA is a ripoff.

"The Institute
has not put out any
official communication on the Covid-19
testing set up at the



Kotoka International Airport," the statement said, adding that only Noguchi's Director, Prof. Abraham Kwabena Annan has the locus to speak on its behalf.

Dr. Bonney had spoken last week on Joy FM, revealing for the first time that the COVID-19 tests being conducted on arriving international travellers at the KIA was the uncertain and cheap antigen tests which often produce partly accurate results.

The antigen test, according to Dr. Bonney cost on average, between \$10 and \$20, however, the Ghanaian government is charging an incredible US\$150.

Indeed, checks by Whatsup News indicates that Ghana may be the country charging passengers the highest in the world for COVID-19 antigen test. Most countries conduct the more accurate PCR test for the deadly disease and it cost an average of US\$ 150.

Meanwhile, reports indicate that over US\$40,000 has been generated from Covid-19 tests since the country opened up for international travel on September 1, in what has increasingly been seen as Ghana's curious profiteering from COVID-19.

President
Akufo-Addo gave the order for the reopening of international travel, claiming doctors had developed a rapid testing system that can give results quickly.

The National Disaster Management Organization (NAD-MO) says it has organized some relief items. However, Regional NADMO Director, John Alhassan Kweku, says ongoing heavy downpour has made it impossible to reach people.

agement was shocked by the disappearance of some old trophies from the storeroom," a statement from the FA said.

The statement added that an investigation has been launched. "The Egyptian Football Association is now investigating the trophies' disappearance to determine if those old trophies were saved after the building was burned ... or if they were lost when the building was exposed during this incident."

In 2013, the headquarters of the FA was raided by angry fans forcing authorities to transfer various trophies into a storeroom.

Officials searched for them recently after a decision to renovate the FA office' entrance so that Egypt's laurels could be displayed.

## Rawlings Supports Wife's Acclamation As NDP Presidential Candidate



he Founder of the National Democratic Congress (NDC), Jeremiah John Rawlings, was the guest of honour at the ceremony to acclaim his wife as the Flagbearer of the also-ran National Democratic Party (NDP), in what has sent shivers down the NDC.

Even though the event was virtual due to the raging Covid-19 pandemic, Mr. Rawlings made sure to grace the occasion. Rawlings antics have been interpreted as divisive by some wor-

ried members of the main opposition NDC who refer to the glaring absence of the party's founder during the acclamation of the presidential candidate, John Dramani Mahama.

Nana Konadu founded the NDP in bitterness and after she failed in the contest for the flagbearer of the NDC in the lead up to the 2012 elections. The humiliating defeat to then-President Mills had sent Rawlings on a path of choosing between his wife and the party he founded "with

his blood".

Mrs. Rawlings, who together with her husband had become very critical of Mills over Mills' refusal to prosecute corrupt former appointees of the John Kufuor government then formed the NDP, which at the time many believed was aimed to diffuse NDC votes, but then the perceived plan failed badly because the NDC and John Mahama went on to win the 2012 elections.

The NDC has since also lost the 2016 elections but Mr. Rawlings

and his wife's antics at the NDC may present a difficult reconciliation for the NDC which is struggling to claw back from opposition.

Meanwhile, the founder and newly confirmed flagbearer of the NDP, Mrs Rawlings says her political journey is borne out of a sense of service to humanity rather than personal ambition.

"The upcoming general election is really not about me or my individuality but about our nation and our future. We should try to refocus our lenses as a people on long term national development visions," she said.

The NDP had been disqualified from contesting in the 2012 Presidential elections after it became obvious they were not prepared for that election. Again, in 2016, the party barely polled 17,000 votes out of over 12 million votes and scoring an insignificant 0.16% of total votes cast nationally for the presidential elections.

## EC Unveils Voters' Register Exhibition Schedule Amidst Rigging Suspicion

he Electoral Commission (EC) of Ghana has set September 18th to 25th as the dates for the exhibition of the newly compiled voters register across the country.

This is coming in the wake of intense suspicion that the EC may be up to something fishy with the register.

Last week, the opposition National Democratic Congress (NDC) revealed an explosive content of a secret tape capturing the Deputy

Bono East Regional Minister, Oti Gyaaka revealing how the Electoral Commissioner, Jean Mensah, after the exhibition of the register plans to delete thousands of names from areas known to be strongholds of the NDC.

Mr. Gyaaaka's alleged voice was also hinted that EC's data during the elections will be transmitted and routed to a master computer in the possession of the NPP which will be manipulated to give the governing party a win in the December

general elections.

Meanwhile, the EC claims the exhibition of the register will afford Ghanaians the opportunity to check and confirm their particulars in the register.

Making the announcement, Director of Elections for the Commission, Dr. Serebour Quarcoo also urged Ghanaians who registered to partake in the exhibition exercise.

"This is a new compilation so there is a need for everybody to go and check his or her particulars. All should go to the centre, get a request form and show your voters' identification card," he said.

The compilation of new voters register by the EC was between June 30, 2020, and August 6, 2020, after countless protests from the NDC and some Civil Society Organisation about attempts to use the register to rig the 2020 elections.

Although the EC had projected registering 15 million eligible voters, the Chairperson for the Commission, Jean Mensa revealed that some 16,663,669 people were registered onto the new electoral roll.




### NDC's People's Manifesto Has No Empty Promises - Running Mate

Prof. Jane Naana Opoku Agyemang, the running-mate to former President John Dramani Mahama and flagbearer of the National Democratic Congress (NDC), has promised that the party's manifesto contains no unrealistic plan.


### Octopus Gabby In Court Again Over Dirty Agyapa Deal

Otchere-Darko, the powerful cousin of President Akufo-Addo,
has flashed a lawsuit again over his alleged involvement in the stinky Agyapa Royalties deal.

The ubiquitous right-hand-man of President Akufo Addo, linked to several controversial deals in the past few years, has sued Mrs. Zita Benson, a former Tourism Minister in the erstwhile Mills government, for defamation for suggesting that he has his long tentacles in Agyapa deal.

According to Gabby, Mrs. Benson's allegations are "absolutely false," and a deliberate attempt to defame him.

In a video post on Facebook, the former Tourism Minister pointed out the involvement of Gabby's



law firm, Africa Legal Associates LLP, in the deal as legal advisors even though Ghana has a fully functioning Attorney General and proceeded to link Gabby's Radio Station-Asaase FM to the royalties deal that has set off widespread red flags in Ghana and abroad.

"Who are the peo-

ple involved in Agyapa? Our own senior Minister, Osafo Marfo's son is behind it. Gabby Otchere Darko is in it as a lawyer and he claims he doesn't know about it. He claims he did not know about it and is even going to court but today he himself confirmed that is privileged to be the lawyer of Agyapa," she said.

However, according to Gabby in the write seen by Whatsup News, he is never involved in the Agyapa deal as a shareholder as is being alleged.

This is not Gabby's first time of heading to court over the same allegation. Barely a month ago, he also sued the MP for Bia East, Richard Acheampong, for similarly pointing out that the octopus smells with suspicion over the Agyapa dirty deal.


# President of House Of Chiefs, Togbe Afede Hints At Agyapa's Shadiness

he President of the National House of Chiefs, Togbe Afede XIV has aired his opinion about the controversial Agyapa Royalties deal after attempts by faceless people dragged him into the discourse, using a forged letter purporting to be coming from him.

Togbe, who is also the Agbogbomefia of Asogli in the Volta Region said the arrangement for Ghana to incorporate Agyapa in a tax haven makes no sense to him.

"I, in particular, I'm very much hurt by the attempt to use my name to grant legitimacy to a transaction that has been very widely condemned for its secrecy and for the fact that the company involved, Agyapa, was incorporated in a tax haven. i do not see why desperation on the part of anybody who is associated with that transaction to want to use the name of innocent Togbe Afede XIV," the powerful Chief said.

The Chief who is also an investment banker made his thoughts known after some faceless people used his name to condemn for-



mer President John Mahama, for sharing a post that ascribes the opacity of the Agyapa dirty deal to the so-called Akyem Mafia.

A rather convoluted arrangement with the fingerprints of rip-off merchants all around it, Agyapa personifies a Special Purpose Vehicle that was set up using the Minerals Income Investment Fund (MIIF). The MIIF had been set up to pool the mineral incomes of Ghana for de-

velopment.

To give it the personality of a company, the Akufo-Addo government went to Parliament and used its majority advantage in Parliament to change the establishing law for MIIF. MIIF was then given the power to put together a Special Purpose Vehicle (SPV)-Agyapa and use it to borrow US\$-1billion from the London Stock Exchange using 5% mineral royalties from

mining companies as collateral.

These investors are to give Ghana, first a lump sum of US\$500million, however, income that Ghana gets from its mineral resources, is US\$200million every year. Meaning in the next five years, the country can depend on its mineral incomes to raise the US\$1billion.

According to Togbe Afede XIV, "I've never commented on this kind of transaction and I have decided not to comment for good reason...tax havens typically serve two purposes; helping you to avoid tax or ensure secrecy."

"I don't see why a national transaction should be shrouded in secrecy in the first place and if we are trying to avoid tax or minimize tax. Who are we denying tax payments to? The corporation is incorporated in Ghana, tax will accrue to Ghana which will be paid by this company that is owned, supposedly, majority by Ghana so i do not see why we should be doing that investment," Togbe Afede said.

# "Bawuah" -Leader of Top-Secret Assassin Squad Pops Up



he Akufo-Addo government has allegedly put together an assassination squad and stationed it at the seat of Government, the Jubilee House.

Ongoing investigation keeps throwing up "Bawuah" as the surname of the leader of the squad who will be used to target some personalities run-up to the December elections.

These disturbing revelations are coming on the back of revelations by the opposition National Democratic Congress (NDC) that it has seen secret tapes that unveils an insidious plan by the governing NPP to unleash large scale violence during the December general elections.

According to inside sources, the name of the killing squad's leader is hidden in plain sight so that spotting the exact "Bawuah" can be tricky. However, investigations have so far thrown up the names of likely candidates.

ers. He was born in Tamale and was enlisted into the military on the 18thOctober 2000 with a BECE certificate and was dishonourably discharged on the 7th of July 2010 for misconduct.

Mr. Bawuah Adomako attended Basic NCO tactics; Regimental and had his younger brother, COLLINS BAWUAH and himself, along with their father, Ex WO1 Bawuah, who worked as a storeman, living in ABF barracks during his father's service days.

The third potential agent is one L/Cpl BAWUAH BRIGHT, formerly of 3 Battalion; while the fourth is Staff Sergeant Bawuah who has reportedly been dismissed for extorting money from people under the pretext of helping them enlist into the army.

According to sources, the killing squad has between 50 and 5000 soldiers in rogue service and it is purposed to eliminate persons that are marked out for it.

The alleged existence of this killing machine is illegal as the Constitution of the Republic of Ghana recognizes only one standing army, the Ghana Armed Forces (GAF).

these farmers are a national asset and specialists within their field? They are an integral part of the industrial hempvolution that is set to take off in 2021 and should be recognized as such. Yes we will fly in experts from all over the world who will also apply themselves to assisting in our development adding value as they go along but they do not have the affinity with Ghana like our indigenous farmers do. Our farmers are Ghana and Ghana is our farmers!

All they need right now is a little hemperstanding because they are in the middle of a transition from illegal cultivation to legal cultivation. The cultivation of cannabis is a generational model that stretches back almost over a hundred years if not more. Families are able to keep a roof over their heads and feed and sustain themselves all because of the cultivation of cannabis. I am not suggesting in any way shape or form that farmers should break the law; certainly not! But those who have unlicensed firearms are given a period of time known as an "Amnesty" when they can bring in unlicensed firearms with no questions asked.

So why can't we bear in mind that in a few months' time the cultivation of cannabis indica (weed) will be outlawed like it has never been before? With the improved powers that the **Narcotics Control Commission will** have anyone caught will end up losing everything they own including their liberty. A little hemperstanding will lead the authorities to realise that we are in a state of transition. Livelihoods are at stake; men, women and children are all under threat with such potential raids, what purpose will it really serve targeting the small scale cannabis farmers and letting the big cocaine dealers go
