### GOVT'S EMPLOYS VOODOO ARITHMETICS TO CONFUSE STRANDED MICROCREDIT CUSTOMERS



The voodoo mathematics of the Akufo Addo administration has been exposed in the latest announcement that it has released GHC3.56 billion in cash to fully settle locked up funds of depositors in the 370 microfinance companies that were collapsed by the government.

Incidentally, President Akufo Addo himself had said early August 2020 that over 98% of all funds of these stranded depositors have been settled.

"All those who had deposits in the banks, all of them, their monies have been refunded... Let me repeat it: All those whose savings were in the banks, all those savings have been refunded and paid to the people" President Akufo Addo told Koforidua-based Sunrise FM. Since then, the Finance Ministry, the receiver of these collapsed institutions and government appointees have corroborated the president's statement.

A simple calculation will mean if 98% of the funds have been settled by the government, the GHC 3.6 billion announced by the government as the last tranche of the settlement will equal the remaining 2% that is outstanding. Essentially, the government is saying that the total funds locked up in the collapsed microfinance institutions and banks, total over GHC 117 billion or US\$ 23 billion.

This amount is almost half of Ghana's entire GDP! However, the intrigue gets even more curious, because in December 2019, Finance Minister Ken Ofori Atta went to the Ghanaian Parliament to ask for GHC 15 billion as the total amount needed to settle the stranded customers of the collapsed microfinance institutions. "In view of the foregoing, and the need to protect the financial sector, Parliament is respectfully requested to consider and approve expenditure of up to Fifteen **Billion, Six Hundred Million** Ghana Cedis (GH¢15.6 billion) for the bailouts of depositors and investors; and for ensuring that liquidity in the financial system is improved thereby safeguarding the financial sector and the economy. This amount covers all the fiscal interventions in the financial sector starting 2017," the memo indicated in its conclusion,"


basis for the entire calculation of the so-called locked up funds.

The serious discrepancies, coupled with accusations from affected customers that the government is engaging in deception, is giving a serious cause to worry about.

The affected customers numbering over 3.3 million people have threatened to vote against the governing New Patriotic Party (NPP) for causing their predicaments. They have composed themselves into what is known as Association of Affected Customers of Savings and Loans institution which insist that the Akufo Addo's claims of repaying them is "untrue".

According to Ezekiel Annor, the head of the Association only about 297,000, which is less than 10% of the total number of stranded customers have received their monies.

From 2017, the Akufo Addo administration embarked on a contentious financial sector clean-up that has seen over seven indigenous banks collapsed, and almost 400 non-bank financial institutions closed down for an alleged liquidity issues. However, critics have pointed out that the government deliberately collapsed these companies, leading to hundreds of thousands of lost jobs and some 3 million people losing their deposits.

## **OKADA RIDERS REJECT GOV'T & BAWUMIA'S 'FAKE' PROMISE**



namused Motor **Riders Association** of Ghana (Okada) have rejected Vice President Mahamudu Bawumia's promise that the New Patriotic Party (NPP) administration will provide them with alternatives to their controversial trade. Dr. Bawumia, against the tide of the rat race by the Ministry of Transport and other government appointees to hold "consultations" to legalise Okada, announced yesterday that the NPP will not legalize Okada but will provide an alternative and "safer means of transport" for the 600,000 people estimated

to be engaged in the commercial motorcycle business "Okada".

"(Okada riders) need to graduate from this risky and less risky Okada riding to a safer means of transportation," said Dr. Mahamudu Bawumiah at an MoU signing event with German carmaker. Volkswagen and another automobile manufacturer called Blacklvy, in Accra. However, the riders have rejected the offer downright, saying they are not interested in any alternatives and that all they want is a proper legal framework and safety regulations that will make the burgeoning mode of transportation safter for the significant number of Ghanaians who rely on their services.

"...The youth have already involved themselves so we are expecting regulations on it. We are Okada riders. We are not drivers so if they will give us a car, when are we going to learn to drive. Even if you are driving, still you are in danger. How many of us can you give us a car because we are thousands across the nation?" The National Chairman of the Association, Fatawu Ali, told Onua FM. "We don't agree to that [the alternative arrangements promised by the

Vice President]. We like the Okada because even residents in the Vice President's village are using Okada. We need to find a safety solution instead of the car," Fatawu said.

Dr. Bawumia's announcement has totally messed up the government's narrative around Okada as it becomes clear that the Akufo-Addo government is not too sure of what to do with the Okada business question after the administration has strangely announced it was in "consultations" to legalise Okada after the flagbearer of the opposition National **Democratic Congress (NDC)** had announced that if voted into power in December, he will legalise the booming commercial business.

According to the NDC flagbearer, ex-President John Dramani Mahama, legalising Okada is one of his priority projects if voted into power in the December presidential polls. Opponents of the Okada, business have pointed out the unenviable safety record of these commercial motorcycles. However, the group's Chairman said, comparatively, commercial cars are cumulatively killing or maiming more people in Ghana than motorbikes.

# **DANGER! AS EC VOTER REGISTER IS REPORTEDLY CORRUPTED**



he Electoral Commission's (EC)'s scheduled voter exhibition on September 18, 2020, may not materialise following damning revelations that a bulk of the EC's voters data could have been lost or compromised.

The EC has already postponed the exhibition exercise twice-from September 11, 2020, to September 16, 2020.

ponements are a result of the EC attempting to micro-manage the hot mess.

Whatsup News gathered that during the just-concluded new voters registration exercise, officials had done offline registration with intent to transfer data into the EC's system later.

However, when time came for the transfer to be effected, the EC's technicians realized that a lot of the data that had been captured offline had somehow been corrupted and made irretrievable. In one Polling station where 2000 voters were registered, only 100 of the registrants' data was recovered, according to a source. After the EC's technicians had tried for a long time and failed to retrieve the data, a decision was taken

to retrieve hard drives of the biometric devices and reset them in attempt to trick the system into opening up. However, the system responded by wiping out thousands of the captured data, sources say.

Already, the EC had hinted that the brand-new register is bloated with foreigners, and minors, and had appointed a committee to manually correct those alleged anomalies.

However, investigative journalist, Kevin Ekow Taylor thinks that the entire situation is part of a grand agenda of the EC to rig the December 2020 elections for the ruling NPP.

According to WhatsUp News sources, the Jean Mensah led EC is now munching on the idea of returning to the old voters' register. However, the conundrum with this tentative decision is that Constitutional Instrument (C1) 94, which governed the 2016 elections has been amended by Parliament.

Party (NPP).

According to sources, the data corruption mess on the hands of the EC means that the EC may likely be constrained to exhibit the register, constituency by constituency; rather than by Polling Station. In the new format, people with fake biometric cards can then have their data transferred to various constituencies where they can verify their names using the multiple formats that the new system is capable of.

Once such people are able to do multiple verifications, leeway is created for them to vote multiple times during elections.

Meanwhile, the new BVRs that the EC has brought into the country, are said to be only 5,000, a number that is very inadequate for the whole of the country which operates over 30,000 registration centres.

No official statement has been issued from the EC to explain the postponement as the reports of a data corruption gains ground. Should these reports be confirmed, the EC boss, Jean Adukwei Mensah would have wasted some GHC 443 million which was the budget for the new register that critics fruitless contested as needless.

WhatsUp News has been finding out from insiders that the EC's indecision is driven by a big problem that the EC's data transfer, and that voter records of many Ghanaians have allegedly been corrupted on the EC's servers and all attempts by the EC to retrieve them have proven futile.





# WUNTUMI IS MOST FOUL -MOUTHED POLITICIAN-REPORT



he Ashanti Regional Chairman for the ruling New Patriotic Party (NPP), Bernard Antwi Boasiako, alias "Chairman Wuntumi" has been crowned as the most abusive and foul-mouthed politician on radio and television.

Wuntumi's new rating is consistent with that of his political party, which was also adjudged the party with the highest occurrence of indecent expressions for August. The survey was conducted by the Media Foundation for West Africa (MFWA), which pinpointed Wontumi's radio station, Wuntumi Radio in Kumasi as the conduit for this insults and barbaric behaviour. "The August edition

of the Media Foundation for West Africa's (MFWA) Language monitoring on radio has cited the Ashanti Regional Chairman of the ruling NPP, Bernard Antwi Boasiako, also known as Chairman Wontumi, as the most abusive individual on radio."

"The NPP and Kumasi-based Wontumi Radio recorded the highest incidents followed Chairman Wontumi are the Member of Parliament for Assin Central and owner of Ken City Media, Kennedy Ohene Agyapong (Hon.) and the host of Power FM's Inside Politics, Mugabe Maase.

According to MFWA, a total of 99 indecent expressions were recorded by 34 individuals.

The 99 indecent expres-

tributing to peaceful elections through issues-based campaigning devoid of hate speech and indecent expressions that could heighten tension and feed into election-related violence.

In the breakdown, the NPP recorded 50 indecent expressions, followed by the National Democratic Congress (NDC) with 9, the Progressive People's Party (PPP) with 3 and the Ghana Consolidated Popular Party (GCPP) clocked 2.

Madam Akua Donkor's Ghana Freedom Party (GFP) and Percival Kofi Akpaloo's Liberal Party of Ghana (LPG) recorded 1 indecent expression each.

12 out of the 15 radio stations monitored recorded indecent expressions.

Kumasi-based Wontumi Radio recorded 34 indecent expressions on its morning show.

Pro-NPP Oman FM recorded 28 indecent expressions on two of its major programmes being Boiling Point (24) and National Agenda 4. The National Media Commission (NMC), Ghana Independent Broadcasters Association (GIBA) and the Ghana Journalists Association (GJA) have equally been encouraged to use these findings and subsequent ones to inform remedial actions and processes.

## AGYAPA IS AKUFO ADDO'S DESPERATION - DR. BUSIA'S DAUGHTER

## Public Sector Nurses And Midwives Declare Strike From Monday

The ailing public has been notified that from Monday, the 21st of September, they may have to turn to private health facilities for care because there will be no Nursing and other important support staff at the public hospitals to run to.

Nurses, midwives, Physician Assistants (PAs) and Anaesthetists (CRAs) in the public sector are withdrawing their services over what

they say are poor conditions of service.

"the general public is advised to seek medical attention from other health facilities," a statement from the Ghana Registered Nurses and Midwives Association said.

The statement which is dated the 17th of September is signed by Perpetual Ofori-Ampofo, President of the Association.

The decision comes

after a series of meetings with the government over the health workers' condition of service. The first ended inconclusively after it was held on September 3, 2020.

Subsequently, ther have been follow up meetings on September 15 and 16.

According to the Association, the government's stance throughout the negotiations has sidestepped Act 651 of the Labour Law, Section 97 of which deals with issues of good faith for stakeholders.

"The proposal of the employer as reported cannot serve the economic interest of all nurses, midwives PAs and CRAs," the Association's release said.

It said Government's stance improved a little but was not enough to be accepted.
